Five weeks after payment #2, Northwestern Technological Institute will distribute \$200.00 to all Title IV eligible students who are in attendance. Note: CARES Act funds only apply to those students who were enrolled and attending the program when the COVID-19 National Emergency was declared.

Five weeks after payment #3, Northwestern Technological Institute will distribute an equal amount of all remaining funds to all Title IV eligible students who are in attendance. Note: CARES Act funds only apply to those students who were enrolled and attending the program when the COVID-19 National Emergency was declared.
